If your order is subject to recurring charges, then you consent to our charging your payment method on a recurring basis without requiring your prior approval for each recurring charge, until such time as you cancel the applicable order. We reserve the right to correct any errors or mistakes in pricing, even if we have already requested or received payment.

We reserve the right to refuse any order placed through the Services. We may, in our sole discretion, limit or cancel quantities purchased per person, per business, or per order. 6. FREE TRIAL

We offer a 14-day free trial to new users who register with the App. The account will not be charged and the subscription will be suspended until upgraded to a paid version at the end of the free trial.

7. 3 MONTHS FREE

When you subscribe to any Oomph CRM plan or add-on, you'll automatically receive 3 months free. The discount is applied instantly when you sign up for one of our subscriptions. at the end of your 3 Free Months you will be charged monthly/annually for the services subscribed to. *Offer ends 1st December 2024*

8. ACI GROUP CUSTOMERS

We reserve the right to provide free access to The App, for up to 10 users, to selected customers who undertake business activity with Affiliates of the Company. Affiliates include our parent company and any subsidiaries, joint venture partners, or other companies that we control or that are under common control with us.

In such instances the customer will be entitled to free access for each 12 month period from registration of the first user (the Free Period). Free access shall automatically renew at the end of each Free Period, provided sufficient business activity has been undertaken with the Affiliate in the preceding Free Period.

In the event there has been insufficient business activity with the Affiliate in the preceding Free Period, then we reserve the right to commence subscription charges from the end of that preceding Free Period. We reserve the right to determine at our discretion whether the level of business activity has decreased to an insufficient level.

9. DATA RETENTION AND DELETION POLICY FOR TENANTS

Trial Tenants (Non-Paying)

Trial tenants will have their accounts retained for 30 days after the expiration of the 14-day trial period. After this 30-day retention period, the tenant account will be permanently deleted. Notifications will be sent to the registered email address 1 day and 7 days prior to the deletion date.

Tenants Without an Active Subscription (After Cancellation)

For tenants without an active subscription following a cancelled subscription, the account will be deactivated after 90 days. Deactivated accounts will remain in our system for an additional 90 days, after which they will be permanently deleted (a total of 180 days from the date of subscription cancellation). Notifications will be sent to the registered email address 7 days and 1 day prior to the deletion date.

Paying Tenants (Active Subscription)

Paying tenants with an active subscription will not be subject to deletion, and their accounts will be retained indefinitely, provided the subscription remains active.

Important Note

Once a tenant account has been deleted, all associated data is permanently removed and cannot be recovered. We strongly recommend downloading or backing up any necessary information prior to the deletion of your account.

country of residence. Oomph Works Ltd and yourself both agree to submit to the non-exclusive jurisdiction of the courts, which means that you may make a claim to defend your consumer protection rights in regards to these Legal Terms in the United Kingdom, or in the EU country in which you reside.

17. DISPUTE RESOLUTION

Binding Arbitration

Any dispute arising from the relationships between the Parties to these Legal Terms shall be determined by one arbitrator who will be chosen in accordance with the Arbitration and Internal Rules of the European Court of Arbitration being part of the European Centre of Arbitration having its seat in Strasbourg, and which are in force at the time the application for arbitration is filed, and of which adoption of this clause constitutes acceptance. The seat of arbitration shall be London, United Kingdom. The language of the proceedings shall be English. Applicable rules of substantive law shall be the law of the United Kingdom.

Restrictions

The Parties agree that any arbitration shall be limited to the Dispute between the Parties individually. To the full extent permitted by law, (a) no arbitration shall be joined with any other proceeding; (b) there is no right or authority for any Dispute to be arbitrated on a class-action basis or to utilise class action procedures; and (c) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.

Exceptions to Arbitration
